APPRENTICESHIP

Office of Apprenticeship

Program Description: ApprenticeshipUSA offers employers in every industry the tools to develop a highly skilled workforce to help grow their business. For workers, ApprenticeshipUSA offers opportunities to earn a salary while learning the skills necessary to succeed in high-demand careers. Apprenticeship programs range from one (1) year to six (6) years, but the majority programs are four years in length. During the program, the apprentice receives both structured, on-the-job training (OJT) and job-related education. For each year of apprenticeship, the apprentice will normally receive 2,000 hours of on-the-job training and a recommended minimum of 144 hours of related classroom instruction.

Services Provided: Participants who are newly hired (or already employed) earn wages from employers during training and the programs must meet national standards for registration with the U.S. Department of Labor (or federally-recognized State Apprenticeship Agencies). The apprenticeship programs provide on-the-job learning and job-related technical instruction. On-the-job learning is conducted in the work setting under the direction of one or more of the employer's personnel and training results in industry-recognized credentials. Often Registered Apprenticeship sponsors work directly with community colleges that ultimately provide college credit for the apprentice. After completion of an apprenticeship program, the apprentice earns a nationally recognized credential from the Department of Labor that is portable and stackable. Additionally, along with earning a paycheck throughout the apprenticeship, an apprentice is also elevated to journeyworker status that leads to increased pay and upward career opportunities.

Veterans on the Job Training (OJT) and Apprenticeship (APP) Programs

Program Description: The South Carolina Commission on Higher Education Veteran's Education division acts as the Approving Agency that approves programs where veterans and those eligible for VA education benefits can achieve quality training in either an educational, professional, or vocational objectives. Those eligible are able to use their GI Bill benefits for on-the-job training (OJT) and Apprenticeship (APP) training. It is possible to receive a monthly educational benefit check from the Department of Veteran Affairs (VA) for training in an approved OJT or APP program. OJT is training received while actually performing a job and earning wages. OJT programs must be at least six months up to two years in length to qualify. Apprenticeship training is OJT coupled with technical instruction (minimum 144 hours per year).

Services Provided: Apprenticeship programs are normally from two to five years in length. A program may be backdated for up to one year for benefit purposes. The South Carolina State Approving Agency (SAA) approves and monitors the OJT/APP training programs and serves as a liaison between participants and the VA. The SAA does not place veterans in jobs / apprenticeships or offer training. The veteran or eligible person must already be employed in order to use GI Bill benefits for an OJT or apprenticeship program. Once/If your employer is approved you must complete an OJT/APP enrollment packet. **NOTE**: Not all occupations can be approved.

EDUCATION

Adult Education

Program Description: Adult Education programs are available through local school districts, technical schools, vocational rehabilitation centers, and many other institutions and agencies. Programs are designed to allow adults to earn a state high school diploma, to prepare them to pass the High School Equivalency Test (G.E.D), or to meet individual needs for upgrading educational levels.

Services Provided: Adult Education in South Carolina offers a range of program accessibility, certified instructors, current curriculum materials, especially computer-based materials, and instructional resources. Programs provide individual learning plans supported by individual instruction. Instruction is delivered in small groups, whole groups, and in contextualized classroom learning. Program staffs consistently monitor attendance and readiness for assessment to move students toward a High School Diploma (HSD), High School Equivalency Degree (HSED), and/or Career Readiness Certificate (CRC), as well as transition them to post-secondary education and/or employment as expediently as possible.

Career and Technology Education

Program Description and Services Provided: The mission of the Office of Career and Technology Education is to provide leadership and services to districts and schools supporting

grade-level, standards-based curricula through the integration of academic and career and technical instruction for students in grades seven through twelve. Each career cluster identifies different pathways from secondary to two- and four-year colleges, graduate school, and the workplace. The Career and Technology Education program is for all students who plan to pursue work or postsecondary education in those chosen career paths following high school graduation.

National Career Readiness Certificate

Program Description and Services Provided: Provides contextualized instruction in preparation for the WorkKeys assessment. The WorkKeys assessment comprises the National Career Readiness Certificate (CRC): Locating Information, Reading for Information and Applied Mathematics. In addition to preparing for the WorkKeys assessment, individual can also be administered the WorkKeys exam. WorkKeys is a job skills assessment system that helps employers select, hire, train, develop, and retain a high-performance workforce. This series of tests measures foundational and soft skills and offers specialized assessments to target institutional needs.

Vocational Rehabilitation

Program Description: Vocational Rehabilitation prepares and assists eligible South Carolinians with disabilities to achieve and maintain competitive employment. In collaboration with community partners and agencies, technical colleges and universities, and non-profit organizations, Vocational Rehabilitation offers a customized approach to employing veterans with disabilities. Veterans may be eligible for selected services that do not duplicate those provided by the Veterans Administration.

Services Provided: Through counseling, career guidance and vocational assessment, clients are able to identify their abilities and develop skills so they are empowered to choose a career to be successful and become independent. Job retention services help employers retain their employees, by assisting those who are experiencing physical or emotional concerns jeopardizing their employment (including alcohol and other substance abuse) thus allowing those employees to become their most valuable asset. There is no cost for this service, which allows our business partners to maintain the leverage needed to stay competitive.

Technical Education

Program Description: The South Carolina Technical College (TEC) System is the state's largest post high school educational system. FOR DISCRIMINATION PROBLEMS OR QUESTIONS

SOUTH CAROLINA HUMAN AFFAIRS COMMISSION

Program Description: The South Carolina Human Affairs Commission was created to encourage fair treatment, eliminate and prevent unlawful discrimination, and foster mutual understanding and respect among all people in the state. The Commission strives to alleviate problems of discrimination through the enforcement of the South Carolina Human Affairs Law, the South Carolina Fair Housing Law, and the South Carolina Equal Enjoyment and Privileges to Public Accommodations Law.

Services Provided: The mission of the South Carolina Human Affairs Commission is to eliminate and prevent unlawful discrimination in employment on the basis of race, color,

national origin, religion, sex, age, and disability; housing on the basis of race, color, national origin, religion, sex, familial status, and disability; and public accommodations on the basis of race, color, national origin, and religion. The vision of the Commission is to be well known with a positive image and a mission that is understood and accented by the public.

Reemployment Rights – (USERRA)

Program Description and Services Provided: Protects the job rights of individuals who voluntarily or involuntarily leave employment positions to undertake military service or certain types of service in the National Disaster Medical System. USERRA also prohibits employers from discriminating against past and present members of the uniformed services and applicants to the uniformed services.

ESGR, a Department of Defense program, was established in 1972 to promote cooperation and understanding between Reserve Component Service members and their civilian employers and to assist in the resolution of conflicts arising from an employee's military commitment.

ESGR informs and educates Service members and their civilian employers regarding their rights and responsibilities governed by the Uniformed Services Employment and Reemployment Rights Act of 1994 (USERRA). ESGR does not have statutory authority to enforce, but serves as a neutral, free resource to employers and service members. ESGR's trained ombudsmen provide mediation of issues relating to compliance with USERRA.

The Uniformed Services Employment and Reemployment Rights Act (USERRA) protects service members' reemployment rights when returning from a period of service in the uniformed services, including those called up from the reserves or National Guard, and prohibits employer discrimination based on military service or obligation. The U.S. Department of Labor's (DOL) Veterans' Employment and Training Service (VETS) administers USERRA.

South Carolina Commission for the Blind

Program Description: The South Carolina Commission for the Blind helps blind and visually impaired residents of our state gain independence and take advantage of opportunities for financial advancement. Working with a network of businesses, community and government partners, they provide training, job placement and business opportunities for thousands of South Carolinians each year. Offices are conveniently located throughout the state and referrals are taken for services from physicians, family members, community partners or potential clients and are provided free of charge.

Services Provided: The mission of The South Carolina Commission of the Blind is to provide quality individualized vocational rehabilitation services, independent living services and prevention of blindness services to blind and visually impaired consumers leading to competitive employment and social and economic independence. Rehabilitation services, adjustment to blindness training, prevention of blindness, independent living services and various other services are provided to blind and severely visually impaired South Carolinians.

These services are made available with state and federal funding and there is no charge to consumers for services. Eligibility for most services is contingent on meeting the legal definition of blindness: having a central visual acuity of 20/200 in the better eye with best corrective lens or a visual field of 20 degrees or less. Individuals with a severe visual disability that will result in legal blindness also are eligible for services. Legal blindness must be verified by an acceptable eye examination.

South Carolina Division of Veterans' Affairs

Program Description: The mission of the SC Division of Veterans' Affairs is to be the advocate for the state's veterans in all matters that pertain to veterans. The SC Division of Veterans' Affairs assists all veterans, of all wars in which their service may have been rendered, in filing, presenting and prosecuting to final determination all claims which they have for money compensation, hospitalization, training and insurance benefits under the terms of federal legislation. These services are extended to eligible dependents, including parents, widows, children and orphans of veterans. The Office administers the Free Tuition Program for certain war Veterans' children. It also must provide administrative support for the Veterans' Trust Fund Board of Trustees. In addition, the Office is mandated to provide training for the forty six County Veterans' Affairs Officers.

Services Provided: The State of South Carolina offers special benefits for its military Service members and Veterans including Income Tax Exemption on Retirement Pay, Property Tax Exemptions, State Employment Preferences, Education and Tuition Assistance, Vehicle Tags, as well as Hunting and Fishing license privileges. Eligibility for some benefits may depend on residency, military component and Veteran disability status among other benefits.

Program Description: The Columbia Regional Office provides Compensation and Pension, Vocational Rehabilitation and Employment, Educational and Burial benefits to eligible veterans, dependents, and survivors residing in the state of South Carolina. In November 2007, the Columbia Regional Office came on line with the first of eight National Call Centers. The Columbia Regional Office has out-based offices in Charleston and Greenville, SC. Approximately 421,000 veterans reside within the regional office jurisdiction. **Disability Compensation**: Disability compensation is a monetary benefit paid to veterans who are disabled by an injury or illness that was incurred or aggravated during active military service. These disabilities are considered to be service-connected. Disability compensation varies with the degree of disability and the number of veteran's dependents, and is paid monthly. Veterans with certain severe disabilities may be eligible for additional special monthly compensation. The benefits are not subject to federal and state income tax. The payment of military retirement pay, disability severance pay and separation incentive payments known as SSB (Special Separation Benefits) and VSI (Voluntary Separation Incentives) affects the amount of VA compensation paid to disabled veterans.

To be eligible, the service of the veteran must have been terminated through separation or discharge under conditions other than dishonorable. For additional details, visit www.vba.va.gov/bin/21.

Pension: Veterans with low incomes who are permanently and totally disabled, or are age 65 and older, may be eligible for monetary support if they have 90 days or more of active military service, at least one day of which was during a period of war. (Veterans who entered active duty on or after September 8, 1980, or officers who entered active duty on or after October 16, 1981, may have to meet a longer minimum period of active duty.) The veteran's discharge must have been under conditions other than dishonorable and the disability must be for reasons other than the veteran's own willful misconduct. Payments are made to bring the veteran's total income, including other retirement or Social Security income, to a level set by Congress. Unreimbursed medical expenses may reduce countable income for VA purposes.

Vocational Rehabilitation & Employment – VR&E

You may receive Vocational Rehabilitation and Employment (VR&E) services to help with job training, employment accommodations, resume development, and job seeking skills coaching. Other services may be provided to assist Veterans in starting their own businesses or independent living services for those who are severely disabled and unable to work in traditional employment.

The program provides services leading to employment or help for individuals to live more independently. These services include vocational counseling, training, career placement, and special rehabilitation services available to eligible active duty Service members, Veterans and dependents. Eligibility:

A Service member must:

- 1. Expect to receive an honorable or other than dishonorable discharge upon separation from active duty.
- 2. Have a VA memorandum (or preliminary) disability rating of 20% or greater.
- 3. Apply for Vocational Rehabilitation and Employment (VR&E) VetSuccess services.

A Veteran must:

- 1. Have an honorable or other than dishonorable discharge.
- 2. Have a VA service-connected disability rating of 10% or more.
- 3. Apply for Vocational Rehabilitation and Employment (VR&E) VetSuccess services.

Entitlement: Veterans are eligible if they:

- Have received a discharge that is other than dishonorable
- Have a service-connected disability rating of at least 10% from VA
- Apply for VR&E services

Basic period of Eligibility:

The basic period of eligibility ends 12 years from the date of notification of one of the following:

- Date of separation from active military service, or
- Date the veteran was first notified by VA of a service-connected disability rating.

The basic period of eligibility may be extended if a Vocational Rehabilitation Counselor (VRC) determines that a Veteran has a Serious Employment Handicap.

Burial Benefits: Veterans discharged from active duty under conditions other than dishonorable and service members who die while on active duty as well as spouses and dependent children of veterans and active duty service members may be eligible for VA burial benefits. The veteran does not have to predecease a spouse or dependent child to be eligible.

With certain exceptions, active duty service beginning after September 7, 1980, as an enlisted person, and after October 16, 1981, as an officer, must be for a minimum of 24 consecutive months or the full period of active duty (as in the case of Reservist or National Guard members called to active duty for a limited duration.) Eligibility is not established by active duty for training in the Reserves or National Guard.

Reservist and National Guard members, as well as their spouses and dependent children, are eligible if they were entitled to retired pay at the time of death, or would have been, if over age 60.

VA national cemetery directors verify eligibility for burial in their cemeteries. A copy of the veteran's discharge documents specifies the period(s) of active duty and character of discharge, along with the deceased's death certificate and proof of relationship to the veteran (for eligible family members) are all that are usually needed to determine eligibility.

Under Section 2411 of Title 38 of the United States Code, certain otherwise eligible individuals found to have committed federal or state crimes are barred from burial or memorialization in a VA national cemetery and from receipt of government-furnished headstones, markers, burial flags, and Presidential Memorial Certificates.

Education Benefits

Montgomery GI Bill Eligibility – VA education benefits may be used while the service member is on active duty or after the service member's separation from active duty with a fully honorable military discharge. Discharges "under honorable conditions" and "general" discharges do not establish eligibility.

Eligibility generally expires 10 years after the service-member's discharge. However, there are exceptions for disability, re-entering active duty, and upgraded discharges.

All participants must have a high school diploma, equivalency certificate, or have completed 12 hours toward a college degree before applying for benefits.

Types of Training Available: The following are types of training that are available:

1. Courses at colleges and universities leading to associates, bachelors, or graduate degrees, including accredited independent study offered through distance education.

2. Courses leading to a certificate or diploma from business, technical or vocational schools.

3. Apprenticeship or on-the-job training for those not on active duty, including selfemployment training begun on or after June 16, 2004, for ownership or operation of a franchise.

4. Correspondence courses, under certain conditions.

5. Flight training, if the veteran holds a private pilot's license upon beginning the training and meets the medical requirements.

- 6. State-approved teacher certification programs.
- 7. Preparatory courses necessary for admission to a college or graduate school.
- 8. License and certification tests approved for veterans.
- 9. Entrepreneurship training courses to create or expand small businesses.

10. Tuition assistance using MGIB as "Top-Up" (active duty service members).

Post 9/11 GI Bill: The Post 9/11 GI Bill provides financial support for education and housing to individuals with who have served at least 90 aggregate days on active duty on September 10, 2001, or were honorably discharged from active duty with a service-connected disability after serving 30 continuous days following September 10, 2001. You must have received an honorable discharge to be eligible for the Post 9/11 GI Bill.

The Post 9/11 GI Bill will pay tuition based upon the highest in-state tuition charged by a public educational institution in the state where the school is located. The amount of support that an individual may qualify for depends on where they live and what type of degree they are pursuing.

The Post 9/11 GI Bill will pay eligible individuals:

- Tuition & fees directly to the school not to exceed the maximum in-state tuition & fees at a public Institution of Higher Learning.
- For more expensive tuition, a program known as the "Yellow Ribbon Program" exists which may help to reimburse the difference.
- A monthly housing allowance based on the Basic Allowance for Housing (BAH) for an E5 with dependents as the location of the school.
- A books and supplies stipend of up to \$1000 per.

The Post 9/11 GI Bill can be used at colleges, universities, trade schools, and for on-the-job training, apprenticeships, and flight schools. To see what programs are currently approved for VA benefits, go to <u>www.benefits.va.gov/gibill/</u>.

eBenefits: The President's Commission of Care for America's Returning Wounded Warriors (Dole/Shalala) established by Executive Order 13426 in March 2007 recommended the creation of a My eBenefits (a.k.a. eBenefits) web portal to provide the wounded, injured and ill service members/Veterans, their families and care providers a single sign-on, central access point to online benefits and related services.

The eBenefits portal is a one-stop shop for benefits-related online tools and information. The portal is designed for Wounded Warriors, Veterans, Service member, their families, and those who care for them.

eBenefits provides two main services. It is a catalog of links to information on other websites about military and Veteran benefits and it provides a personalized workspace called My eBenefits which gives quick access to all the online tools now integrated into eBenefits. These tools allow veterans to apply for benefits, download DD 214 forms, and see benefits status online. Service members, veterans, and family members can register for eBenefits, which affords access to the secure features in My eBenefits and allows the portal to be personalized to the user's needs. Veterans must be enrolled in the Defense Enrollment Eligibility Reporting System (DEERS) to create an account.

Home Loan Guaranties: VA home loan guaranties are issued to help eligible service members, veterans, reservists and unmarried surviving spouses obtain homes, condominiums, residential cooperative housing units, and manufactured homes, and to refinance loans.

If the insurance policy number is not known, send whatever information is available, such as the veteran's file number, date of birth, Social Security number, military serial number or military service branch and dates of service.

Launched in 2003, My HealtheVet is a free, online Personal Health Record that empowers Veterans to become informed partners in their health care. VETERANS AFFAIRS MEDICAL CENTERS

VA Medical Centers – The VA provides complete medical care covering the full range of medical services for eligible veterans. Eligibility for VA health care is divided into two categories: mandatory and discretionary. VA must provide medical care to mandatory category veterans at the nearest VA facility capable of furnishing the care in a timely fashion. If no VA facility is available, care must be furnished in a Defense Department facility or another facility with which the VA has a sharing or contractual relationship. If space and resources at VA hospitals are available after caring for mandatory care patients, VA may then furnish care to veterans in the discretionary category, if they agree to pay VA for their care.

Veterans who must be provided hospital care and are not subject to an income eligibility assessment are: veterans with service connected disabilities, veterans who were exposed to herbicides while servicing in Vietnam, veterans exposed to ionizing radiation during atmospheric testing or in the occupation of Hiroshima and Nagasaki, veterans for a condition related to service in the Persian Gulf, former prisoners of war, veterans on VA Pension, veterans of the Mexican Border period of World War I and veterans eligible for Medicaid. Outpatient medical treatment includes examination and related medical services, pharmacy services, rehabilitation services, and mental health services. As part of outpatient medical treatment, veterans may be eligible for home health services for the treatment of disabilities.

Nursing Home Care

Nursing care in VA or private nursing homes may be provided for veterans who are not acutely ill and not in need of hospital care. VA may, but it is not mandated to provide nursing home care if space and resources are available in VA facilities. Veterans who have a service connected disability are given first priority for nursing home care.

Domiciliary Care

Domiciliary care provides rehabilitative and long-term health maintenance care for veterans who require minimal medical care but, who do not need the skilled nursing services provided in nursing homes. VA provides domiciliary care to veterans whose annual income does not exceed the maximum annual rate of VA pension and to veterans the Secretary of Veterans Affairs determines have no adequate means of support.

Vet Centers

Vet Centers across the country provide a broad range of counseling, outreach, and referral services to combat Veterans and their families. Vet Centers guide Veterans and their families through many of the major adjustments in lifestyle that often occur after a Veteran returns from combat. Services for a Veteran may include individual and group counseling in areas such as Post-Traumatic Stress Disorder (PTSD), alcohol and drug assessment, and suicide prevention referrals. Transition Assistance Program (TAP)

Program Description and Services Provided: TAP consists of comprehensive three-day workshops at selected military installations nationwide. Professionally-trained workshop facilitators from the State Employment Services, military family support services, Department of Labor contractors, or VETS' staff present the workshops. Service members leaving the military with a service-connected disability are offered the Disabled Transition Assistance Program

(DTAP). DTAP includes the normal three-day TAP workshop plus additional hours of individual instruction to help determine job readiness and address the special needs of disabled veterans.

In accordance with Public Law, TAP services shall be made available to all eligible Service members and their spouses, commencing 12 months prior to anticipated separation or 24 months prior to anticipated retirement. Separating service members should attend 90 days prior to separation. In the event there are 90 or fewer days before the un-anticipated retirement or separation of a service member, participation in TAP services shall begin as soon as possible within the remaining period of service. Similar to their Active Duty counterparts, Reserve Component members deactivated after more than 180 consecutive days must also complete mandated TAP requirements unless otherwise exempted.

2. Go to Veteran's Affairs, or the Courthouse, and record a copy of your DD 214 form.

4. File for unemployment.

5. If you were injured or have an ongoing ailment while on active duty, register and file a claim with Veteran's Affairs.

6. Need financial planning classes (how to handle mortgages and rent) see the Urban League, telephone: (803) 799-8150.

7. Register with the VA Health Care system call: (803) 779-4000, ext. 7196

8. South Carolina bar referral service (1-800-868-2284). Free legal services (divorce/child support/etc.).

9. Uniformed Services Employment and Reemployment Rights Act (USERRA – this is for veterans that are called to serve while in the workforce and have difficulty being re-employed in their jobs. Call: U.S. DOL VETS (803) 737-7650 or ESGR (803) 299-2515.

10. State Vocational Rehabilitation for disabilities that are not service connected.
